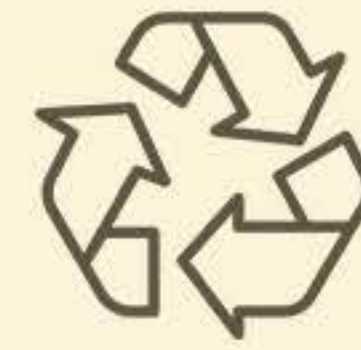

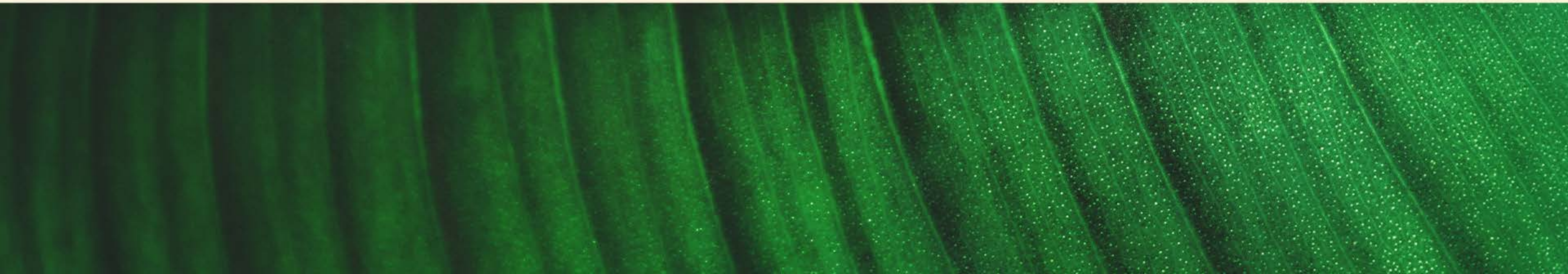

WHAT IS EIA?

Environmental Impact Assessment is a systematic process that examines the
ENVIRONMENTAL CONSEQUENCES OF AN ACTIVITY TO:

Bio-physical environment & Socio-Economic environment
And designing appropriate environmental management measures to mitigate
negative consequences and enhance positive ones



PROJECT TYPES AND DECIDING AUTHORITY

Are all development projects required to undertake EIA Study?

Project Type	Decision document	Requirement	Mandated Office
Category A Projects (ECPs)	Environmental Compliance Certificate (ECC)	EIS or EPRMP (for existing projects with expansion)	EMB Central Office
Category B Projects (Non ECPs)	Environmental Compliance Certificate (ECC)	EIS or EPRMP or IEE Checklist	EMB Regional Office concerned
Category C Projects (Environmental Enhancement)	<i>To be determined upon submission of Project Description</i>	<i>To be determined upon submission of Project Description</i>	EMB Regional Office concerned
Projects not covered by PEISS	Certificate of Non-Coverage (CNC)	Project Description	<div>AUTOMATIC APPROVAL</div>

• Projects prior to 1982 are not covered unless there is modification/expansion
